## Appendix F – Hunt County Cemetery Data

### Process Summary

After review of Texas Historical Commission (THC) data and Internet research, preliminary Hunt County spreadsheets and maps were prepared and mailed to the Hunt County Historical Commission (CHC) and THC for review and comment in early 2010. The CHC was asked to update and refine the database as necessary. Using the data collected, TxDOT TTA’s consultants added and updated cemeteries with the most accurate information based on driving directions and Global Positioning System coordinates received from the CHC.

This appendix includes data on a total of 122 Hunt County cemeteries, 119 which are mapped cemeteries plus 3 cemeteries believed to be in the county, but with insufficient information to map. TxDOT TTA’s consultants confirmed the location of 63 of 119 mapped cemeteries through study of aerial imagery and maps.

#### Explanation of the spreadsheet column headings

For consistency, the following information is reported for each cemetery (a full description for each column is noted):

- **Map Resource Number** – The number used to identify the cemetery on the Cemetery Map. (Note that the cemeteries are numbered generally from north to south.) Below the list of mapped cemeteries, there is a list of cemeteries that research indicated are located within the county, but for which there was insufficient information to map a cemetery location. These cemeteries are designated as Unmapped No. 1, Unmapped No. 2, etc.
- **Symbology for Map** – Notes TxDOT’s estimate of the accuracy of the mapped cemetery location as reflected by up to four symbols used on the map:
  - **Cemetery mapped accurately (within 0.5 miles)** - A confident determination of a cemetery’s location based on aerial imagery, Google Maps Street View, Bing Maps Bird’s Eye View, a given address or intersection, or cemeteries previously mapped in THC’s GPS Survey database. For cemeteries mapped with this symbol, the accuracy level ranges from an exact location to a mapped location within 0.5 miles of the actual location.
  - **Cemetery mapped at approximate location (within 3 miles)** – TxDOT mapped an approximate cemetery location in instances where enough information was provided to make an educated guess on the general location, yet not enough

information was provided to verify the location. Resources that TxDOT typically used in their efforts to locate cemeteries for this report include: aerial imagery, internet mapping sites, and cited online sources. The accuracy level for the cemetery location ranges from greater than 0.5 miles up to 3 miles of the mapped point.

- **Cemetery reportedly destroyed** - A cited source reported that the cemetery was destroyed, meaning that the cemetery has been damaged to a point that there is not much evidence of its existence. Future field investigation could determine if a cemetery still exists at the site.
- **Graves reportedly moved** - A cited source reported that the graves of the cemetery were moved to another location. Because TxDOT did not do field work for this report, they are not certain if all the graves were moved. Such a location would require field work by specialized personnel to determine if there are any graves remaining at the site.
- **Cemetery Name** – The cemetery name used on the Cemetery Map.
- **THC Cemetery Number** – The cemetery number assigned by THC in THC GPS Survey data or the online THC Historic Sites Atlas. (Source: THC)
- **THC Cemetery Name** – The cemetery name that THC assigned in the THC GPS Survey data, online THC Historic Sites Atlas, and if applicable, THC RIP Survey Data. (Source: THC)
- **Also Known As (AKA)** – All names referring to the cemetery. The sources for the AKAs included THC, the County Historical Commission, and Internet sources listed in the bibliography for this county.
- **Latitude Used for Mapping** – Coordinates for mapped cemeteries using Geographic Coordinate System NAD83, Decimal Degrees (Y-axis).
- **Longitude Used for Mapping** – Coordinates for mapped cemeteries using Geographic Coordinate System NAD83, Decimal Degrees (X-axis).
- **Location Confirmed?** – A “Yes” in this column indicates that staff has confirmed the location of the cemetery through one of the following methods: 1) Visual confirmation using online aerial imagery; or 2) Cemetery is labeled in at least one of the map sources consulted for the project. Visual confirmation may vary from a large well-defined cemetery with headstones visible in aerial imagery to a small cemetery plot with clear demarcation of a grave site on aerial imagery.
- **Nearby City/Landmark** – A nearby city or landmark identified during cemetery research and labeled on the Cemetery Map created by TxDOT. Information in this column is included to assist readers in locating cemeteries on the Cemetery Map by referencing the labeled features.
- **Best Available Location Information/Notes (Edited and Formatted for Report)** – Contains what TxDOT TTA consultants believe to be the most accurate location information available for each cemetery after comparison of information from THC, the CHC, and Internet research.
- **Location Description\* Source: Texas Historical Commission** – Contains the location information that TxDOT TTA consultants found in the THC Historic Sites Atlas or, if

available, information from the THC Record Investigate, Protect (RIP) Survey data used in the Phase One mailing to CHCs. An asterisk was used to indicate information reported in this column is reported verbatim.

- **Location Description\* Source: As Cited** – Contains location information collected from sources other than THC used in the Phase One mailing to CHCs. All information in this column is reported verbatim from each referenced source.
- **Information Provided by the County Historical Commission\*** – Contains information sent in by the CHC in response to TxDOT TTA's request for cemetery information. Information is reported verbatim from the CHC unless text is enclosed in brackets [ ] to indicate information such as [Marked on map by CHC.].
- **TxDOT Notes**– Contains explanations on staff decisions. Notes conflicts between THC data and other data collected as well as TxDOT TTA consultant resolutions to those conflicts as a reference for THC.
- **Source of Mapped Location** – Source(s) used to determine the mapped location.
